



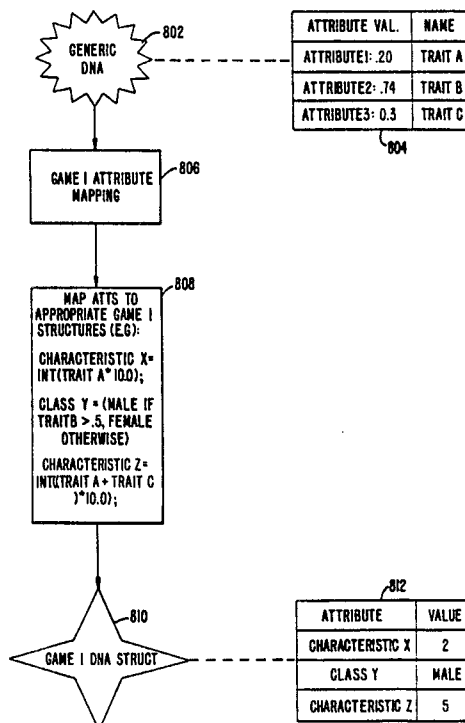

(54) Title: NETWORKED COMPUTER GAME SYSTEM WITH PERSISTENT PLAYING OBJECTS

(57) Abstract

The mapping of playing objects (806) from one game to another. In one embodiment, generic attributes (802) of an object may be mapped to game-specific attributes (812). The mapping may either change or maintain the look and feel to an object. For example, a fast but lightly-armed starship in one game may be mapped to a quick but weak warrior in another game.
